<p>The study on the status quo has been conducted with several meetings in three different countries, Italy, Belgium and Spain.</p> <p>Thanks to these meetings, partners managed to meet in person:</p> <ul style="list-style-type: none"> - 13 may, Brussels : Presentation of the project to EU Commission (Vito Borrelli, DG EAC, Head of Erasmus Programme) and Helene Benegas, EACEA, in charge of ESAA and discussion on the Green Deal perception by citizen and next steps of EU Green Deal and eco-sustainability policies to come - 14 may, Brussels : presentation of the project and conséquent discussion on Green Policies in the field of education with AEF (Fanny Lutz, Silvia Paradela and Patrick Meuwissen), representatives of 7 HEIs in Wallonie and further discussion with Elodie DECOSTRE and Cindy Regnier (ARES), Anke Van Bylen and Celine Jambon (policy officer at DG EMPL). - 23 may, Brussels, discussion in a small focus group with Amir Fattal (Molengeek) and SECO manager (Salon for European Civic organiations) Alain Deneef and 2 CSOs at SECO premises. - 27 may, Vicenza with the mayor and the Youth focus group of the municipality, gathering 5 representatives of local CSOs, discussing on their initiatives on the topic. - 5 june, Cordoba, meeting with municipality and focus group with 4 NGOs active in the field of ecosustainability and 2 schools, in order to ahve a wider overview on the topic. - 7 june, Altavilla Vicentina, meeting with the new mayor to exchange views and prospective initiatives on the topic - 11 june, Vicenza meeting with 2 NGOs working on ecosustainability to co-promote a citizens'questionnaire. <p>Thanks to these meetings, we managed to get a clear picture of the status quo of perception of EU Green Deal and eco-sustainability policies by citizens in the three countries, and set the basis for a fruitful project implementation.</p> <p>During these visits, we also assessed the project Child Safeguarding Strategy, and submitted it to all stakeholders for review and awareness raising and managed to develop and internal Gender Equality and social inclusion plan and a Greenkeeping plan, in order to have a green project implementation</p>
